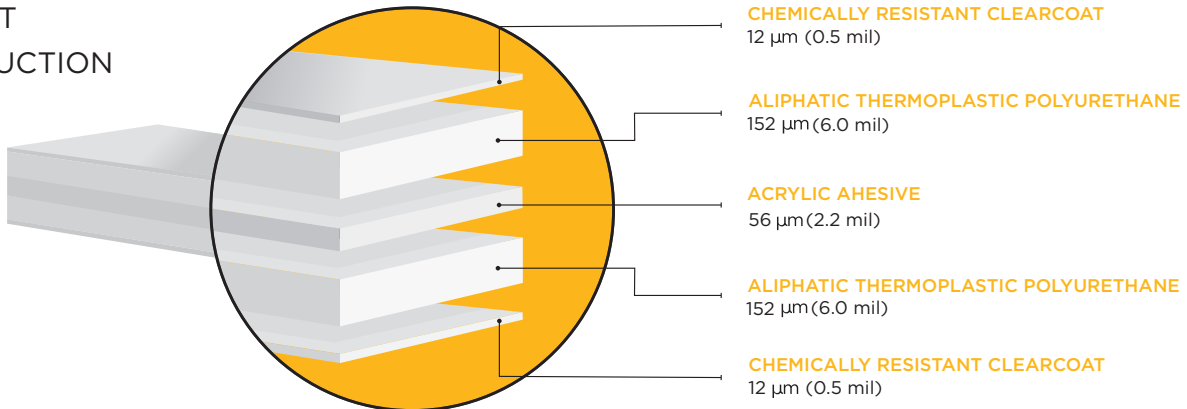


FACE SHIELD TECHNICAL DATA SHEET



The XPEL **FACE SHIELD** is constructed of an aliphatic TPU-based (Thermoplastic Polyurethane) product. Typical physical properties of our product include transparency, elasticity and resistance to oil, grease and abrasion. The **FACE SHIELD** is constructed with a very low surface energy film designed to resist staining and offers superior environmental resistance and protection. The clear coat employs special elastomeric polymers that allow minorscratches in the surface to “heal” over time, leaving line of sight unobstructed.
